However, if your child is graduating this school year (2008-2009), the remaining tuition balance plus all other financial obligations are due by May 15, 2009.

The Parent(s) or Guardian(s) shall make all payments when they become due, and if not made within thirty (30) days, then the Parent(s) or Guardian(s) shall be in default of this Agreement and the school shall have the right to terminate this enrollment and disallow the Student to attend further the After School Extended Care Program at the School. Further, the school shall be entitled to collect and receive all remaining balances due under this Agreement regardless of the Student's withdrawal or dismissal. In addition, the Parent(s) or Guardian(s) will incur all costs and attorney's fees for such default. Should you decide to withdraw your child during the school year, attendance of three (3) days within a month will warrant a full month fee payment.

It is further understood that should payments be made with personal checks or other money instruments, which are returned unpaid for any reason, St. Francis Catholic School will automatically add an additional \$40.00 returned check service fee plus collection agency fee and all future payments will be on a cash only basis.

St. Francis Catholic School may at its discretion refer the outstanding account without notice to Parent(s) or Guardian(s) to its Collection Agency or Attorney and all applicable fees will be the responsibility of the Parent(s) or Guardian(s).

Parent(s) agree that: (i) the terms and conditions of St. Francis School’s Parent Student Handbook are hereby incorporated by reference herein, and are agreed to by Parent(s); (ii) all graduating eighth graders’ Parent(s) having delinquent accounts as of May 15, 2009 shall not be entitled to have their Student graduate, take exams, or otherwise receive their transcripts or graduating certificate; and (iii) Parent(s) shall pay returned check fee of \$40.00 in addition to the check amount.

Parent(s) agree that in the event of a breach of this agreement, such as late payment, in addition to the above remedies, St. Francis School shall have the right to not admit Student and/or seek damages against Parent(s) for all cost incurred in enforcing this Agreement,

including, but not limited to, attorneys' fees and costs, statutory prejudgment interest, and collection agency fees. Additionally, St. Francis School shall have the right to waive, in its sole discretion, tuition amounts due in the event Student withdraws or is expelled from school.
